


Interest-Based Advertising and Media Notice

Effective Date: June 21, 2021

1. General Information About This Notice

- This notice is to provide our customers (“you”) with information about how we use interest-based advertising and our Loblaw Media service to provide tailored advertisements to you.
- Interest-based advertisements are advertisements from us or our clients that we hope you find more relevant to your interests. It is important to us that you receive advertisements relating to our products and services or third party products and services that interest you.
- We deliver interest-based advertisements to your device by using cookies or other identifiers assigned to your device such as an ad identifier, and by using personal information such as your email address that is protected by industry-wide security standards (hashed email).
- This notice is governed by the [Loblaw Privacy Policy](#). If there is any inconsistency between this notice and the Loblaw Privacy Policy, the Loblaw Privacy Policy will prevail.

2. What is Loblaw Media?

Loblaw Media is an advertising service of Loblaws Inc. that provides Canadian advertisers with the opportunity to deliver more relevant digital advertising to our valued *PC Optimum* members.

For example:

We and our advertising service providers may serve you with an ad on behalf of a beverage provider based on your online and offline beverage purchases.

Once an advertising campaign has been completed, we will provide the client advertiser with aggregate information about the campaign's performance (e.g., the percentage of customers that have received their advertising, in which city or location the ad campaign was most successful, estimated sales conversion).

3. What Information Do We Collect?

In order to deliver interest-based advertisements to you on our websites, mobile applications and other third party websites and mobile applications such as social media platforms, we and third party advertising companies that we engage may use cookies, pixel tags, web beacons, ad identifiers, and other technologies as well as your hashed email address to collect information about your visits to our websites and mobile apps and other websites and mobile apps.

For example, the information we collect may include:

- Products, web pages or advertisements you scrolled over or clicked on or viewed on our websites or mobile applications; and
- Products and services you purchased online on our websites and mobile applications and offline in our stores.

It is important to note that we will not use sensitive data (e.g., health information, financial account information, sensitive product information i.e. data about your personal lifestyle choices or products which may be of an intimate nature such as weight, political or religious affiliations, etc.), for interest-based advertising purposes, without your express consent. Examples of non-sensitive data that we may use for interest-based advertising services include your purchase history of items such as groceries, cosmetics, apparel and household goods.

4. How Do We Use This Information?

We use this information to place you in general interest and purchase categories (e.g., beauty buyers, coffee buyers, organic product buyers), which helps us determine what types of advertisements may be of interest to you and then serve you with these advertisements. We may draw inferences from items you purchase online and/or in-store and use these inferences to gain insights into how well our products or third party products sell to a certain general interest group.

5. How Do We Share This Information?

We may share your personal information within our group of companies for the purposes described in this notice or as detailed in the [Loblaw Privacy Policy](#), and in accordance with applicable law. We also share limited personal information (e.g., hashed email address) with our advertising service providers, such as Facebook and Google, for the purposes of reaching you with relevant advertisements through their advertising platforms.

We do not share personal information with our client advertisers on whose behalf we may serve interest-based advertising, since they only need to know that they are reaching the right customers at the right time and place to make their advertising relevant and whether their advertising campaign was effective. As such, our customers' personal information remains within our control at all times. To learn more, please see the section below on Loblaw Media.

6. What Are Your Privacy Choices?

You can manage your privacy preferences by changing your browser settings on your device, opting-out of or not opting into interest-based advertising in your mobile device or mobile app settings if available (e.g., via Apple or Android based mobile phones) and/or using third party unsubscribe functionality (e.g., via Google or Facebook) to change your preferences within their platforms. Please note that disabling, blocking or deleting some of these technologies, such as cookies, may cause you to lose the functionality of certain features on our websites and apps. You can also opt-out from receiving interest-based advertising from our client advertisers (brought to you by Loblaw Media) or receiving interest-based advertising from us by contacting our Customer Relations Centre at 1-800-296-2332.

It may take some time for all of our records to reflect changes in your preferences. For example, if you request that you not receive interest-based advertising, your preference may not be captured for an advertising campaign already in progress. Please note that, after opting-out of interest-based advertising, you will still see ads but they may not be relevant to you.
