Loblaws Enrolment Form



The Employee Purchase Program gives active associates an ongoing 30% discount off their monthly **in-market** plan (Peace of Mind, Peace of Mind Connect, Simple Share) and add-ons for a period of 24 months. Just a heads up that the discount only applies to the standard monthly rate of a plan or add-on. The discount does not apply to late payment charges, taxes and pay-per-use charges (such as long distance, roaming, additional airtime, data top ups, data fast passes, or pay per use data). Discount is based on rate plan eligibility.

The discount cannot be applied to Loyalty ("L&R" in plan description), non-share, voice only, corporate EPP or winback plans and features unless otherwise specified in the conditions or eligibility on the plan or feature page.

Discounts will be applied within 15 business days of receiving your completed form and proof of employment.

Please note that the discount is not retroactive. The discount will automatically drop off the account after 24 months, so the Associate is required to set themselves a reminder to re-enrol.

Conditions

Participating eligible employees give consent to their employer to disclose their personal information to TELUS for the purpose of verifying ongoing eligibility for the TELUS National Retail Employee Purchase Plan. Personal information includes the eligible employee's first and last name and employee number with his/her participating employer.

The rate discount will remain valid for a period of 24 months. The discount is subject to:

- a) the employee remaining employed with a TELUS authorized National Retailer;
- b) the TELUS authorized National Retailer maintains its participation in the TELUS National Retail Employee Purchase plan; and
- c) the employee maintains his/her account in good standing and using the wireless services in compliance with the applicable terms and conditions.

If any of the above conditions no longer continue to be true, TELUS may, upon thirty (30) days' notice, remove the rate discount from the employee's account. If the employee subsequently cancels his/her contract during the contract term, the outstanding portion of your Easy Payment Balance/Device Balance will apply in accordance with the TELUS terms and conditions of service.

At the end of the 24 month term, the eligible employee may be eligible to receive the rate discount for an additional 24 month term provided that the eligible employee continues to fulfill the eligibility requirements set out and reapplies for the discount.

TELUS reserves the right to discontinue this program at any time without notice.
